# Westover City Council MINUTES April 20, 2021

The meeting of the Council of the City of Westover, Alabama was held in the City Hall in Westover, Alabama at 6:30 p.m. on April 20, 2021.

- <u>Planning Commission</u> Chairman Ed Stowell Absent Wayne Jones reported Doug Eddleman, Eddleman Properties presented Pine Mountain Preserve Village 3 to the Planning Commission. Mr. Eddleman will be meeting with the Shelby County Board of Education regarding a new school site for Pine Mountain Preserve.

Juno Manning, Planning and Zoning Clerk, announced Geostone will be asking for pre-zoning and if the Planning Commission approves will be presented to the City Council.

Mayor Riggins commented that Geostone has been in discussion with Planning Commission members and himself for approximately one year to annex into Westover. The annexation will be to have a Small Block Production Company by the railroad. This would create approximately 25 jobs. This will be presented at the Planning Commission meeting next week to request Pre-zoning. If the Planning Commission recommends zoning as Economic Center Industrial (ECI), this will be presented to the City Council.

- <u>Attorney</u> Mr. William Justice Absent Mayor Riggins reported that Attorney Bill Justice has been busy with several legal items for the City the last few weeks with advise for the Fire Department Bid Contract and the Government Capital Financial Lease Agreement for the Fire Department.

- <u>Westover Fire Department</u> Chief Micah Woodley Provided a handout to the Council and reported the following information:

Chief Woodley updated the Council on the following:

An updated court order to meet the DMV requirements was received and submitted to the State of Alabama to finalize the transfer of the Volunteer Fire Truck and Ambulance into the city's name.

New I-Pads on the Battalion and Engine were placed in service from the FM Global grant in 2020.

All emergency light upgrades have been ordered for the donated Vestavia Fire Truck and we are still working through some issues on a decal vendor. This truck will be placed in service mid-May.

Fire House Subs has awarded the Fire Department with \$22,673.00 for a Wildlife Fire/EMS skid unit for the Mule, storage racks and cancer prevention items. We should have the paperwork finalized and the money directly deposited in our account in mid-May.

The Shelby County Fire and EMS Association has awarded the Fire Department \$4,153.60 in equipment for attendance and involvement in the association during 2020. We used the funds to order needed equipment for the fire truck and upgraded some existing equipment for the fire truck.

FEMA grants selection is scheduled to start on April 30, 2021. We should have a decision on all our requests by late May 2021.

#### **OLD BUSINESS:**

Mayor Riggins reported the Mt. Tabor Parsonage is for sale at \$155,000.00. Due to the lack of not having the Fire Department bids, Mayor would like to postpone any recommendations for the Mt. Tabor parsonage at this time.

Mayor Riggins reported that the remodeling of Mt. Tabor ADA Bathroom is in progress. Mayor will get an update from Todd Destafino this week. Also, the Archives Room at Mt. Tabor Annex has a new lock on the door and a key will be kept at City Hall.

Mayor Riggins reported on the Fire Department Construction project status as discussed in the pre-meeting. No sealed bids were received. L.E. Marcus Construction had mailed their bid but, we have not received in the mail as of today. The bid was emailed April 16, 2021 and the bid was dated April 2, 2021.

Mayor Riggins is asking the Council to approve negotiation of a final Construction Contract with L. E. Marcus Construction. The emailed bid did not include the paving. The Construction Contract will be written and sent to the Council for approval. Mayor Riggins needs pricing to include paving. A motion was made by Councilmember Annette Tyler to approve Mayor to negotiate a new Construction Contract for Fire Department Renovations.

A second was made by Councilmember Susan Lane. Mayor Riggins stated he would send the new Construction Contract to the Council for review as soon as it was finalized.

The approval for Mayor Riggins to negotiate a final Construction Contract was adopted unanimously as presented.

#### **NEW BUSINESS:**

Resolution #2021-04-20-2062 Proclaiming Mental Health Awareness for May was presented. This Resolution was read into the minutes by Bonnie Meacham, City Clerk – Treasurer, as stated under communications.
